CBP authority to regulate air commerce

- 19 CFR Part 122 Air Commerce Regulations
- Electronic information for air cargo required in advance of arrival – 19 CFR 122.48a
 - Airway bill number
 - Flight number
 - Carrier code (ICAO)
 - Airport of arrival
 - Airport of origin
 - Date of arrival
 - Quantity
 - Weight
 - Precise cargo description
 - Shipper's name & address
 - Consignee's name & address
- International Carrier Bonds




Streamlining the Process



Entry Process Comparison – Air Transportation Deep Dive

Description: This process map illustrates the key differentiators and benefits between the current and the new Simplified Entry processes.

Key Process Benefit: Prior to departure, Filers submit a streamlined set of data, allowing CBP to conduct targeting earlier and mitigate risks more effectively

Clearance Process

- Data Acceptance-CBP Review-Issues Resolved-Release
- Data Acceptance-CBP Review-Issues Persist-Freight to bonded facility pending release.
- EXAMINATION REQUIRED



Examination Process

- Does carrier have facilities on Airport Property?
- Yes. CBP send officers, examines freight, finalizes disposition.
- May be a contracted entity (i.e. Quantum)
- No. Freight must be transported to CBP's Central Examination Site (Tax AirFreight)
